100 CLUB" RULES

- 1. The subscription to the "100Club" is payable by monthly or yearly standing order. However, Trustees have discretion to accept a cheque for a yearly or pro rata subscription.
- 2. Members may have multiple subscriptions.
- 3. Membership is open to all over the age of 16.
- 4. The membership year runs from 27th November to 26th November.
- 5. Ticket numbers will be allocated sequentially as application forms are received.
- 6. Tickets will be priced at £5 each per monthly draw or £60 per annum.
- 7. Subscriptions must be received by the 27th of each month to be eligible for the next monthly draw, which will take place on the first Thursday of each month that the Henham Parish Council meet and supervised accordingly or alternatively, when the Parish Council do not meet, in the presence of at least one of the trustees and two other members of the Parish Council.
- 8. Members wishing to join after the membership year has begun may pay monthly, or be charged a pro rata yearly subscription.
- 9. The "100 Club" shall not be limited to 100 members or numbers.
- 10. The decision of the Trustees shall be final in all matters that require adjudication. The Trustees have the right to refuse any entry.
- 11. Each member is allocated a permanent number or numbers, which will remain the member's provided that his or her subscription is up to date.
- 12. Cancellation of subscriptions should be made in writing, preferably by e-mail, after which the relevant numbers will be withdrawn from the following draw.
- 13. Monthly prizes will be awarded according to membership of the "100 Club for that month as follows:

Winner 35% of subscriptions collected for the month

Second Prize 15% of subscriptions collected for the month

Prizes will be rounded down to the nearest whole £.

Additional occasional prizes may be allocated at the discretion of the Trustees.

- 14. Winners will be notified personally as soon as is practically possible and names will be posted in the Village shop, in the Dragon, on the Henham website and Facebook, unless specifically requested not to do so, in which case, the persons name will be deleted and reported as anonymous.
- 15. Payments for prizes will be sent by cheque or online if you prefer to the winners by the 15th of the month following the draw.
- 16. The funds received from member subscriptions and not awarded, as prizes will be periodically credited to Henham Parish Council SOV account.
- 17. Club members will be notified in advance of any amendments or additions to these Rules that may be necessary in future.
- 18. The "100 Club" will be run in accordance with the Gambling Act 2005. Licensed by Uttlesford District Council: Small Society Lotteries Licence No. SL188
